Fees

- The fee for all entries is \$25. No Refunds.
- 1st, 2nd & 3rd Prizes will be awarded based on interpretation of theme.

Acceptable Entries

An entry consists of the following:

- One golf cart - One car - One truck
- One float (vehicle pulling trailer) - Walkers

All entries must be decorated in a family-friendly manner.

Parade Route

All participants must be in place no later than 8:30 AM on Saturday, May 15, 2021. (Alternative date Saturday, September 4, 2021). The parade will begin and end at the Fayette County High School parking lot on Tiger Trail.

Rules

- No candy tossing is allowed.
- No distributing of professional material of any kind.
- All floats or trucks carrying riders ARE REQUIRED to have side rails at least 36" high around riders and must have hand holds for standing participants.
- Participants are not permitted to exit and re-enter a float, or any vehicle, once the parade has started.

That neither the participant nor any member of participant's household has knowingly been exposed to anyone diagnosed with COVID-19 within the past 14 days.

That neither the participant nor any member of participant's household has traveled outside of the country within the past 14 days.

That an inherent risk of exposure to the COVID-19 virus, and any other communicable and infectious disease, exists in any public place where people are present and that the risk of exposure to the COVID-19 virus, and any other communicable and infectious disease, includes the risk that participant will expose others that participant later encounters, even if participant is not experiencing or displaying any symptoms of illness himself or herself.

That Fayette County, the Fayette County Board of Commissioners, and the Fayette County Historical Society cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form or on the form of any other participant.
